Blood can be safely donated every 56 days. Platelets can be given safely every two weeks, up to 24 times a year. Most healthy people age 17 and older, or 16 with parental consent, who weigh at least 110 pounds, are eligible to donate blood and platelets. Donors who are 18 and younger must also meet specific height and weight requirements.
